The meeting started at 11.00 A.M. as the necessary quorum was present. The meeting proceeded with the consideration of the agenda in the following order.

- 1) The proposed syllabus for the subject of Elements of Company Law I and II for S.Y.B.Com. Sem. III and Sem.VI was presented by Dr. Shubhada Tamhankar. The members deliberated on the same and discussed on various matters. Suggestion regarding deletion of one sub-topic from the syllabus more specifically in Unit 2.3 namely "Conversion of one-person company into a private or public company" was accepted and accordingly was deleted from the syllabus. The revised syllabus was then approved unanimously.
- 2) Then the proposed syllabus for the subject of Income Tax for T.Y.B.Com. Sem.V was presented by CA Umesh Kulkarni. The members deliberated on the same and discussed on various matters. The syllabus was then approved unanimously.
- 3) Then the proposed syllabus for the subject of Indirect Taxes for T.Y.B.Com. Sem.VI was presented by CA Hemant Godbole. The members deliberated on the same and discussed on various matters. Suggestion regarding inclusion of one sub-topic in the syllabus more

- specifically in Unit 3 after sub-unit 9 new sub-unit 10 "Introduction to concept of Advance Ruling, few important rulings and their importance" was accepted and accordingly included in the proposed syllabus. The revised syllabus was then approved unanimously.
- 4) Then the proposed syllabus for the subject of Foundation of Mercantile Law I for T.Y.B.Com Sem.V and Allied Concepts in Mercantile Law - II were presented by Mrs. Swati Chiney. The members deliberated on the same and discussed on various matters. The syllabus was then approved unanimously.
- 5) The members were informed about the new format of syllabus in which the present syllabus were presented, namely i) Course learning outcomes, ii) Gist of the course, iii) Teaching methodology iv) Project/field work as a part of continuous assessment, v) Objectives, vi) Learning outcomes, vii) Internship for the students, if any, viii) relevance of the subject, ix) employability, entrepreneurship and skill development and x) cross cutting issues relevant to gender, environment and sustainability. Members appreciated the efforts taken by the faculty members.
