MODE OF APPLYING: - The scheme is implemented through the National Scholarship Portal (NSP). It is mandatory for all students to apply online on the **website i.e. www.scholarships.gov.in.** 

Before filling the application form you have to check the eligibility criteria, guidelines, FAQ's and required documents of the said scheme and submit the hardcopy alongwith necessary documents to the Scholarship Section.

- 1) Print out of scholarship application form duly signed by student
- 2) Income Certificate, issued from a <u>Competent Authority</u> in respect of parent/guardian of the student.
- 3) Previous Std.XII Board Marksheet
- 4) Aadhar card
- 5) Students Bank Account Details
- 6) Fee receipt- 2023-24

## **Eligibility conditions:**

- Students who are above 80th percentile of successful candidates in the relevant stream from a particular Board of Examination in Class XII
- Pursuing regular course (not correspondence or distance mode)
- Having family income of less than Rs.8 lakhs per annum
- Not receiving any other scholarship and fee reimbursement of any kind

## Who can apply for scholarship under CSSS on National Scholarship Portal (NSP)?

a. Students who have completed Class-XII in the Academic Year 2021-22 and who are in the Top 20th percentile list of concerned Board (SEB/CBSE/CISCE) are eligible to apply for fresh scholarship

Those who are not covered in the list would not be able to choose the CSSS scholarship scheme.

b. Students who have applied for fresh scholarship in academic year 2020-21, 2021-22, 2022-23 and 2023-24 and in merit list, can apply on the National Scholarship Portal http://scholarships.gov.in/. for 4th renewal (2024-25), 3rd renewal (2023-24), 2nd renewal (2022-23) and 1st renewal (2021-22) before the cut-off date.

To receive renewal scholarship, it is compulsory for the scheme beneficiaries to apply every year as renewal candidate. If missed out in any academic year, he/she will be debarred permanently. Therefore, applicant should ensure to apply for renewal on portal and ensure his/her application is verified by the Institute, before closure of the portal.

## What is the amount of scholarship under the Scheme?
